## **CONCESSION TUITION FEE FOR ELIGIBLE STUDENTS**

To be eligible for the concession tuition fee, you must be a holder (or dependant spouse or child of aholder) of one of the following cards at the *commencement* of your training:

- Commonwealth Health Care Card
- Pensioner Concession Card



Veteran's Gold Card

We will grant you 30 days after commencement to prove your concession eligibility, however it must be valid from course enrolment process.

Unfortunately, concession rates do not apply to Diploma courses.

All Aboriginal and Torres Strait Islanders will not be charged a tuition fee regardless of their qualification.

# **RPL (RECOGNITION OF PRIOR LEARNING)**

RPL is the process whereby your relevant skills and experience is documented, matched and assessed for units in the qualification you are enrolling into.

RPL costs \$150 per unit.

#### **Credit Transfer**

If applicable credit transfers will be assessed based on evidence provided. If credit transfer is approved then all accounts will adjusted as required to reflect changes in fees payable.

#### REISSUING OF CERTIFICATES OR STATEMENTS OF ATTAINMENT

Unlike other Registered Training Organisations, Are-Able Education and Training does not charge for the reissue of a Certificate or a Statement of Attainment.

#### **REFUNDS FOR GOVERNMENT FUNDED COURSES**

#### WITHDRAWAL BY STUDENT

- If you withdraw before commencing training a full refund of the tuition fee will be given
- If you withdraw in writing within 4 weeks of commencing training a refund of the tuition feewill be given, minus an administration fee of \$75.
- If you withdraw more than 4 weeks after commencing training you are not entitled to a refundof fees, and any outstanding fees still need to be paid.

## **CANCELLATION OF INDIVIDUAL STUDENT ENROLMENT BY Are-Able Education and Training**

 If your enrolment is cancelled after 4 weeks of training, you are not entitled to a refund of tuition fees.

#### **CANCELLATION OF COURSE BY ARE-ABLE EDUCATION AND TRAINING**

- If Are-Able Education and Training must stop delivering the course at any time during your enrolmenta full refund of the tuition fee will be given
- In the unlikely event of the unexpected closure of Are-Able Education and Training, contact the VRQA atvrqa.vic.gov.au. You will be referred to another training organisation to continue your training.



#### **PAYMENT OF FEES**

- An invoice for fees will be issued when you enrol. You will be able to participate in a Direct Debit scheme to pay your fees over an agreed period. The enrolment officer will discuss this with you during your enrolment. There will be no Direct Debit scheme for concession card holders.
- Certificates, Statements of Results, Statements of Attainment or any form of confirmation of unit/course completion will not be issued until all fees have been paid.

## **Terry White Scholarship**

 The Terry White Scholarship initiative is designed to assist learners that enrol an opportunity to study with a partial or full discount of tuition fees.

The scholarship program will see eight successful recipients receive a \$1000 scholarship to help support towards tuition of their chosen field of study from any of the qualifications Are-Able Education and Training Provides.

#### In the areas of:

- Certificate III in Early Childhood Education and Care
- Diploma of Early Childhood Education and Care
- Certificate III in Individual Support
- Certificate IV in Disability

The successful applicant of these scholarships will prove to the selection committee that they are deserving of this by:

- Displaying a commitment to their chosen field of study
- Have a supported testimonial from a chosen referee as to why you would be a good candidate.
- Provide in writing your own testimonial as to why you think you should be considered.
- Why you want to complete your qualification at Are-Able Education and Training.

#### Eligibility Criteria:

- Australian Resident
- Over 17 years of Age
- Have not completed a higher level of qualification than what is being applied for.
- Successful completion of the Pre-Training Review conducted by a Are-Able Education and Training Teacher
- Successful Completion of the Literacy and Numeracy Assessment deemed appropriate for your level of study.
